

16th Annual Take Our Kids to Work™ Program

On Wednesday November 3, 2010, over 200,000 grade 9, Senior 1 (Manitoba) and Secondary III (Quebec) students across Canada will spend the day at work, job shadowing a parent, relative, friend or volunteer host.

What will students get out of the program?

- Develop an appreciation for the importance of staying in school and getting a high school diploma and pursuing post-secondary studies.
 - Gain exposure to the skills required in today's workplaces.
 - Develop an appreciation for their parents' roles in making a living and supporting their families.
 - Begin career discussions with adults about the work they do.
 - Gain a better understanding of the complexity of career choices and the benefits of early exploration.
 - Explore career options in practical ways.

What will parents get out of the program?

- Participate in a shared experience with your child.
 - Begin career discussions and dialogue based on actual experiences.
 - Enrich the experience for your child by providing opportunities to talk before, during and after the visit.

Where can students go for the day?

Where possible, parents invite their own child to spend a day on the job. If you are unable to host your own child, there are still ways for your child to participate. Here are some suggestions:

- Ask a relative, neighbour or family friend to host your child at his/her workplace.
- Contact the school, speak with the principal, career studies or co-op teacher, ask if they can assist you with finding a suitable placement.
- Ask the parent of another grade 9 student who is participating if your child could join him/her for the day.
- Contact local businesses. Ask if they are hosting students for Take Our Kids to Work™. Inquire if someone within their organization would be willing to host your child providing you make the necessary transportation arrangements.

Safety First

Workplace health and safety are vital aspects of the program. It is important that young people receive information about health and safety prior to their workplace visit. They also need to know their rights and responsibilities for jobs they may hold now and in the future. Parents of working students need this same information.

Parents need to be aware of the work that their children engage in and ask questions about the health and safety provisions. The Ultimate Dream Job Contest

In the fall of 2010, The Learning Partnership in partnership with Scotiabank® launched the second annual Ultimate Dream Job Contest. "I lost my hearing when I was 3 years old and drawing has always been a good way for me to communicate. But now, it is my best talent. I practise drawing everyday and I dream about making people enjoy and laugh when they read my comics."

The winner of the 2009 Ultimate Dream Job Contest won an all-expense-paid trip for two to Ottawa on Take Our Kids to Work™ day. Highlights of the trip included meeting The Right Honourable Stephen Harper, Prime Minister of Canada, touring Parliament Hill, The National Gallery of Canada and The Canadian Museum of Civilization.
